Naselle-Grays River Valley School District Legal Description – Jan 23rd, 2011 - Revised

Director District 1

Starting at the intersection of Salmon Creek Rd and State Route 4 W.

Southeasterly and northeasterly on State Route 4 W to the power lines in the northeast part of Seaction 23, Township 10, Range 08W, 0.50 miles northeast of Altoona Pillar Rd (more or less).

Southeast on the power lines to the school district boundary.

Counter-clockwise following the school district boundary to power line in Section 10, Township 11, Range 08W.

Southerly on the power line and access road to Salmon Creek Rd.

South by southwesterly on Salmon Creek Rd to the point of the beginning.

Director District 2

Starting at the intersection of S Valley Rd and State Route 4 W.

Southeasterly and northeasterly on State Route 4 W to the power lines in the northeast part of Seaction 23, Township 10, Range 08W, 0.50 miles northeast of Altoona Pillar Rd (more or less).

Southeast on the power lines to the school district boundary.

Clockwise following the school district boundary to the western crossing of State Route 401.

Easterly and northerly on State Route 401 to the Cement Crk.

North on Cement Crk to the South Naselle River.

Meandering northerly on the South Naselle River to S Valley Rd.

Easterly on S Valley Rd to the point of the beginning.

Director District 3

Starting at the intersection of Salmon Creek Rd and State Route 4 W.

Westerly on State Route 4 W to the Naselle River.

Westerly on Naselle River to O Conner Crk.

North on O Conner Crk to the extension of Naselle Rd.

West and southerly on Naselle Rd to State Hwy 401.

Northerly on State Hwy 401 to State Route 4.

Easterly on State Route 4 to N Valley Rd.

Easterly on N Valley Rd to Big Hill Rd.

Northeasterly and easterly on Big Hill Rd to the county line.

North and east on the county line to Salmon Creek Rd.

Southerly and southwesterly on Salmon Creek Rd to the point of the beginning.

Director District 4

Starting at the intersection of State Route 401 and the Cement Crk.

North on Cement Crk to the South Naselle River.

Meandering northerly on the South Naselle River to S Valley Rd.

Easterly on S Valley Rd to State Route 4 W.

Northwesterly on State Route 4 W to the Naselle River.

Westerly on Naselle River to O Conner Crk.

North on O Conner Crk to the extension of Naselle Rd.

West and southerly on Naselle Rd to State Hwy 401.

Northerly on State Hwy 401 to State Route 4.

Northwesterly on State Route 4 to the school district boundary.

Counter-clockwise on the school district boundary to the western boundary of State Route 401.

Easterly and northerly on State Route 401 to the point of the beginning.

Director District 5

Starting at the intersection State Route 4 and N Valley Rd.

Easterly on N Valley Rd to Big Hill Rd.

Northeasterly and easterly on Big Hill Rd to the county line.

North and east on the county line to Salmon Creek Rd.

Northerly on Salmon Creek Rd the the power line access road in Section 21, Township 11, Range 08W.

North on the power line access road to the power lines.

East and north on the power lines to the school district boundary.

Counter-clockwise on the school district boundary to the northwest crossing of State Route 4.

Southeasterly on State Route 4 to the point of the beginning.

Revisions include correctly adding the reference to Cement Crk that was missing.
